# **Application Area**

GREVEN® AQUA TEC is suitable for the protection against water-soluble workplace substances, e.g. water-based cooling lubricants, diluted acids or alkaline solutions, detergents and disinfectants as well as cement and lime etc.

## **Product Description**

GREVEN® AQUA TEC is a special protective lotion against water-soluble workplace substances. The W/O emulsion is free from silicone.

## **Product Properties**

- The basic principle of skin protection products is based on their emulsion type.
- •The W/O emulsion forms an oleophilic film on the skin, which is an effective barrier against hydrophilic workplace substances. However, this property alone is not sufficient for an effective protection. The effectiveness of the protective film is complemented by medicinal white oil (liquid vaseline), beeswax and fatty alcohols.
- Panthenol has an additional anti-inflammatory effect and supports the skin's natural regeneration capability.
- This concept of active ingredients is complemented by lipid-balancing substances.

# **Application**

Before work and after breaks, apply GREVEN® AQUA TEC carefully on the skin, which previously has been cleaned thoroughly and dried carefully. Rub in the cream evenly, paying particular attention to vulnerable areas such as between the fingers and around the nails. Reapply after longer work intervals. The product should not get into the eyes.
